PROPOSED 2003-04 TUITION AND MANDATORY REGISTRATION FEE SCHEDULES

NOTES:

- 1 For tuition purposes, 12 credit hours or its equivalent, constitute a full load for undergraduate and pharmacy students, nine hours for graduate and professional doctoral students, and ten hours for law students.
- 2 For tuition purposes, part-time students, as well as four-week and eight-week intersession students, will be charged on a per credit hour basis.
- 3 Annual tuition. A half-time tuition rate of \$6,802 for resident students and \$15,998 for non-residents is established for those medical students who have been approved by the College of Medicine Student Progress and Promotion Committee to take a reduced curriculum load. A half-time tuition rate of \$5,948 for resident students and \$14,256 for non-resident students is established for those dental students who have been approved by the Dean of the College of Dentistry to take a reduced curriculum load.

- 1 For fee purposes, 12 credit hours, or its equivalent, constitute a full load for undergraduate students, nine hours for graduate students, and ten hours for law students.
- 2 Student Health coverage is provided year-round, allocating the additional cost over two semesters.
- 3 Student Health coverage is provided for the full academic year, allocating the additional cost over two semesters.

Background: In May 2001 the Council on Postsecondary Education approved tuition setting guidelines to be used by the respective Boards of Trustees and Boards of Regents in setting tuition rates for 2002-04. In September 2001 the University of Kentucky Board of Trustees adopted a tuition schedule, including a 5.5 percent increase for undergraduate, resident students for 2003-04. The

reduction of the University of Kentucky state appropriation by the 2003 General Assembly necessitates an increase in the 2003-04 tuition rates. The proposed tuition rates are in compliance with the Council's guidelines.

Changes in the Mandatory Registration Fee Schedule include a \$3.25 increase for the Student Government Association, a \$2.00 increase in the Student Activities fee, an \$8.00 increase for the Student Center, an \$8.00 increase in the Student Health fee, a new \$2.00 fee for International Affairs, and a new \$8.75 fee for Student Affairs.

The mandatory fees are charged to all students enrolled on the Lexington Campus, in the Medical Center, and at Lexington Community College in accordance with their status as full-time or part-time students. Students taking all of their courses in off-campus locations outside of Fayette and its contiguous counties may have these fees waived. However, if a student who is eligible for this waiver wants to participate in activities supported by these fees, the student must pay the total mandatory fee.
