ACCEPTANCE OF INTERIM FINANCIAL REPORT FOR THE SIX MONTHS ENDED DECEMBER 31, 2023

<u>Recommendation</u>: that the Board of Trustees accept the University of Kentucky consolidated financial report for the six months ended December 31, 2023.

<u>Background</u>: The consolidated financial report includes the financial activities of the University of Kentucky and its affiliated corporations:

- University of Kentucky Research Foundation
- University of Kentucky Gluck Equine Research Foundation, Inc.
- University of Kentucky Humanities Foundation, Inc.
- University of Kentucky Mining Engineering Foundation, Inc.
- Central Kentucky Management Services, Inc.
- Beyond Blue Corporation and its non-profit subsidiary Royal Blue Health, LLC

As of December 31, 2023, the University has recognized \$3,516,522,813 of current funds revenue representing 51 percent of the 2023-24 approved budget of \$6,890,210,400. Expenses and transfers total \$3,159,687,805 or 46 percent of the approved budget.
