## Dear President Capilouto:

My term as an alumni trustee of the UK Board of Trustees expires on June 30, 2024. An election has been held among graduates of the University of Kentucky, as prescribed by statute and by the rules and regulations of the Board of Trustees. In accordance with the rules established by the UK Board of Trustees, the Board of Directors of the UK Alumni Association selected six graduates of the University of Kentucky to be on the election ballot. The ballots were distributed by e-mail on November 30, 2023, to all graduates of the University of Kentucky who had received their degrees as of December 31, 2022, and the votes were received and tabulated by an online system administered by the association. Wilson was a member of the UK Board of Trustees from 1999 to 2005.
