## REAPPOINTMENT TO BOARD OF DIRECTORS UNIVERSITY OF KENTUCKY HUMANITIES FOUNDATION. INC.

<u>Recommendation</u>: that the Board of Trustees approve the following reappointments to the Board of Directors of the University of Kentucky Humanities Foundation, Inc. Dates of original appointments are noted and their actions on behalf of the Board in that period to the present time are ratified as part of this recommendation.

<u>Background</u>: The management of the affairs of the Foundation shall be vested in a Board of Directors whose membership shall consist of at least fifteen members, one of whom shall be the President of the University of Kentucky; one of whom shall be the Provost of the University of Kentucky; one of whom shall be the Dean of the College of Arts and Sciences; one of whom shall be the Dean of the Lewis Honors College; one of whom shall be an alumnus of the Gaines Center Fellowship Program; one of whom shall be a Gaines Fellow who will serve in his or her senior (second) year; and up to two of whom shall be individuals designated by the family of John R. and Joan B. Gaines. The remaining ten members of the Board of Directors shall be appointed from the public-at-large.

These appointments require approval by the Board of Trustees in accordance with the Articles of Incorporation and By-Laws for the University of Kentucky Humanities Foundation, Inc. These nominations are supported by the President and Provost.

<u>Thomas Gaines</u> is the CEO of KBC International Inc. and Gaines Thoroughbreds. He is the son of the Center founders John and Joan Gaines and has served on the UK Humanities Foundation, Inc. Board since 2004 and was reappointed to serve until 2031.

<u>Steve Grossman</u> is the Senior Vice President of Hilliard Lyons and Chair of the Board of Trustees for the Lexington Downtown Development Authority. He has served on the UK Humanities Foundation, Inc. Board since 2004 and was reappointed to serve until 2029.

<u>Donna Hall</u> is an active philanthropist who supports a number of organizations such as the Everglades Foundation Chairman's Advisory Council, the Naples Botanical Garden board, and Berea College's Board of Trustees. She has served on the UK Humanities Foundation, Inc. Board since 2004 and was reappointed to serve until 2029.
