Independent Auditor's Report

Board of Directors Central Kentucky Management Services, Inc. University of Kentucky Lexington, Kentucky

Opinion

We have audited the financial statements of the Central Kentucky Management Services, Inc. (CKMS), a component unit of the University of Kentucky, as of and for the years ended June 30, 2024 and 2023, and the related notes to the financial statements, which collectively comprise CKMS's basic financial statements as listed in the table of contents.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the financial position of CKMS, as of June 30, 2024 and 2023, and the changes in financial position and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audits of the Financial Statements" section of our report. We are required to be independent of CKMS and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CKMS' ability to continue as a going concern for 12 months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

Auditor's Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to
 fraud or error, and design and perform audit procedures responsive to those risks. Such procedures
 include examining, on a test basis, evidence regarding the amounts and disclosures in the financial
 statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of CKMS's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about CKMS's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis be presented to supplement the basic financial statements. Such information is the responsibility of management and, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with GAAS, which consisted of inquiries of management about the methods of preparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Information

Management is responsible for the other information included in the annual report. The other information comprises the listing of the board of directors but does not include the basic financial statements and our auditor's report thereon. Our opinion on the basic financial statements does not cover the other information, and we do not express an opinion or any form of assurance thereon.

CENTRAL KENTUCKY MANAGEMENT SERVICES, INC. A COMPONENT UNIT OF THE UNIVERSITY OF KENTUCKY MANAGEMENT'S DISCUSSION AND ANALYSIS YEARS ENDED JUNE 30, 2024 AND 2023

Central Kentucky Management Services, Inc.'s (CKMS) Management's Discussion and Analysis (MD&A) provides an overview of the financial position and activity of CKMS as of and for the years ended June 30, 2024 and 2023. This discussion has been prepared by management and should be read in conjunction with the accompanying financial statements and the notes appearing in the report.

Financial Highlights

- Total assets increased \$417,953 or 16.7%. The most significant components of this change was an increase of \$280,552 in due from the University of Kentucky and \$128,878 in cash and cash equivalents.
- Total liabilities increased \$417,953 or 16.7%. This change was due primarily to an increase of \$252,205 in accounts payable and accrued liabilities and \$156,431 in the escrow account payable to the UK Healthcare Hospital System.
- Net position remained at \$0.
- Operating revenues decreased \$1,467,686 or 3.6% to \$39,603,736.
- Operating expenses decreased \$1,467,998 or 3.6% to \$39,603,373.

Using the Financial Statements

This financial report consists of three financial statements: the Statement of Net Position; the Statement of Revenues, Expenses and Changes in Net Position; and the Statement of Cash Flows. These financial statements are prepared in accordance with GASB Statement No. 35, *Basic Financial Statements – and Management's Discussion and Analysis – for Public Colleges and Universities*.

One of the most important questions asked about CKMS's finances is whether CKMS is better off as a result of the year's activities. One key to answering this question is the financial statements of CKMS. The Statement of Net Position; the Statement of Revenues, Expenses and Changes in Net Position; and the Statement of Cash Flows present financial information on CKMS in a format similar to that used by corporations and present a long-term view of CKMS's finances. CKMS's net position (the difference between assets, deferred outflows of resources, liabilities, and deferred inflows of resources) is one sign of CKMS's financial health. Over time, increases or decreases in net position indicate the improvement or erosion of CKMS's financial health.

The Statement of Net Position includes all assets, deferred outflows of resources, liabilities, and deferred inflows of resources. It is prepared under the accrual basis of accounting, whereby revenues and assets are recognized when the service is provided and expenses and liabilities are recognized when others provide the service, regardless of when cash is exchanged.

The Statement of Revenues, Expenses and Changes in Net Position presents the revenues earned and expenses incurred during the year. Activities are reported as either operating or nonoperating. The utilization of long-lived assets, referred to as lease assets, is reflected in the financial statements as amortization, which amortizes the cost of an asset over its expected useful life.

Another important factor to consider when evaluating financial viability is CKMS's ability to meet financial obligations as they become due. The Statement of Cash Flows presents information related to cash inflows and outflows, summarized by operating, capital and related financing, and investing activities.

Reporting Entity

CKMS provides collection services for the health care receivables of the University of Kentucky (the University) and its affiliated corporations. All commission revenues are received from these entities and the excess of revenues over expenses is distributed back to these entities. CKMS also provides staffing services to health care facilities for the University on a direct cost reimbursement basis.

CKMS is considered to be an affiliate and component unit of the University because the Board of Directors is appointed by the president of the University and the officers of CKMS are also officers of the University.

<u>Assets.</u> As of June 30, 2024, CKMS's total assets amounted to \$2,915,361. Due from the University of Kentucky totaling \$1,455,476 or 49.9% of total assets was CKMS's largest asset, representing reimbursements owed for staffing services due to the timing of payroll dates. Cash and cash equivalents, CKMS's second largest asset, totaled \$1,434,547 or 49.2% of total assets. Other current assets totaled \$15,644 or 0.5% of total assets and lease assets, net totaled \$9,694 or 0.4% of total assets.

Total assets increased \$417,953 for the year ended June 30, 2024, driven primarily by an increase of \$280,552 in due from the University of Kentucky and \$128,878 in cash and cash equivalents.

<u>Liabilities.</u> At June 30, 2024, CKMS's liabilities increased \$417,953 to a total of \$2,915,361. Accounts payable and accrued liabilities, consisting of accrued wages, expenses, and payroll withholdings, was CKMS's largest liability totaling \$2,164,898 or 74.3% of total liabilities. The remaining liabilities, totaling \$750,463 or 25.7% of total liabilities, include an escrow account payable to the UK HealthCare Hospital System totaling \$740,549 (representing net operating revenue in excess of expenses excluding amortization) and lease liabilities totaling \$9,914.

Net Position. Net position was zero at June 30, 2024.

2023 versus 2022. Total assets decreased \$181,645 for the year ended June 30, 2023, primarily driven by decreases of \$240,127 in due from the University of Kentucky and \$2,322 in lease assets, net offset by an increase of \$60,313 in cash and cash equivalents. Total liabilities decreased \$181,645 due to decreases of \$104,669 in the escrow payable to the UK HealthCare Hospital System, \$74,633 in accounts payable and accrued liabilities and lease liabilities of \$2,343. Total net position remained at zero in 2023 from 2022.

2024. Beginning in March 2023, CKMS collection services for health care receivables was changed to collections for delinquent accounts only. Active account collections for both hospital and physician billings are now processed in a single billing office within the UK Healthcare Hospital System utilizing EPIC software capabilities. Therefore, collections decreased \$331,046,319 or 98.8% that resulted in a reimbursement of \$904,599 in fiscal year 2024 compared to a remittance of \$327,479,756 in fiscal year 2023. Healthcare staffing services increased \$1,194,278 or 3.6%. Overall, total operating revenues decreased \$1,467,686 or 3.6% to \$39,603,736 for the year ended June 30, 2024.

Operating expenses totaled \$39,603,373, a decrease of \$1,467,998 or 3.6% from prior year. The decrease was mainly due to a decrease in legal and professional expenses of \$1,815,200. Beginning in fiscal year 2024, these expenses were paid by UK HealthCare rather than CKMS. Salaries, wages and benefits comprised \$38,993,131 or 98.5% of total operating expenses. Salaries and wages related to staffing and other support provided to the UK HealthCare Hospital System decreased \$444,420 offset by an increase of \$841,632 in employee benefits. Other expenses decreased \$44,501 and communications decreased \$5,542.

<u>2023 versus 2022.</u> During the year ended June 30, 2023, operating revenues increased \$3,168,597 or 8.4% primarily due to a net increase in reimbursements for healthcare staffing services provided for the UK HealthCare Hospital System. Operating expenses increased \$3,168,665 or 8.4% due primarily to increases in salaries and wages related to staffing and other support provided to UK HealthCare Hospital System.

Another way to assess the financial health of an organization is to look at the Statement of Cash Flows. The primary purpose of the Statement of Cash Flows is to provide information about the cash receipts and cash payments made by CKMS during the period. The Statement of Cash Flows also helps financial statement readers assess CKMS's:

- · ability to generate future net cash flows,
- ability to meet obligations as they become due, and
- need for external financing.

Cash provided from operating activities consists of cash receipts of \$4,974,200 related to collections and reimbursements net of collections from the University and its affiliated corporations, and \$34,485,840 related to the reimbursements for staffing services provided for the UK HealthCare Hospital System. Cash payments for operating activities were primarily made to employees for salaries, wages, and benefits of \$38,741,636. Cash used for capital and related financing activities consists primarily of principal and interest payments on leases totaling \$2,516.

<u>2023 versus 2022.</u> The net increase in cash of \$60,313 was due to cash provided by operating activities offset by cash used by capital and related financing activities.

Capital Assets and Debt Administration

<u>Capital and Lease Assets.</u> Capital assets, net of accumulated depreciation, totaled \$0 at June 30, 2024, no change from 2023. Lease assets, net of accumulated amortization, totaled \$9,694 and \$581 at June 30, 2024 and 2023, respectively.

Debt. CKMS does not have any debt outstanding as of June 30, 2024 or 2023. Lease liabilities totaled \$9,914 and \$597 at June 30, 2024 and 2023, respectively.

Factors Impacting Future Periods

Effective July 1, 2024, CKMS will no longer provide staffing services to UK HealthCare and all CKMS employees, including Eastern State Hospital employees, will become UK employees. Therefore, healthcare staffing services revenue as well as related personnel expenses will no longer be recorded by CKMS. CKMS will source staffing from UK Healthcare to perform collection services.

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Reporting Entity

Central Kentucky Management Services, Inc. (CKMS) provides collection services for the health care receivables of the University of Kentucky (the University) and its affiliated corporations. All commission revenues are received from these entities and the excess of revenues over expenses (excluding amortization) is distributed back to these entities. CKMS also provides staffing services to health care facilities for the University on a direct cost reimbursement basis. Substantially all CKMS transactions are with the University. CKMS is considered to be an affiliate and component unit of the University because the Board of Directors is appointed by the president of the University and officers of CKMS are also officers of the University.

Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America as prescribed by the Governmental Accounting Standards Board (GASB). GASB establishes standards for external financial reporting for public colleges and universities and requires that resources be classified for accounting and reporting purposes into the following net position categories:

- <u>Net investment in capital assets</u>: Capital and lease assets, net of accumulated depreciation and amortization, and outstanding principal balances of debt attributable to the acquisition, construction or improvement of those assets.
- <u>Restricted:</u>

Nonexpendable – Net position subject to externally imposed stipulations that they be maintained permanently by CKMS.

Expendable – Net position whose use by CKMS is subject to externally imposed stipulations that can be fulfilled by actions of CKMS pursuant to those stipulations or that expire by the passage of time.

• <u>Unrestricted</u>: Net position whose use by CKMS is not subject to externally imposed stipulations. Unrestricted net position may be designated for specific purposes by action of management or the Board of Directors or may otherwise be limited by contractual agreements with outside parties.

The financial statement presentation is intended to provide a comprehensive, entity-wide perspective of CKMS's assets, deferred outflows of resources, liabilities, deferred inflows of resources, net position, revenues, expenses, changes in net position and cash flows.

Summary of Significant Accounting Policies

<u>Accrual Basis.</u> The financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues are recognized when earned and expenses are recorded when an obligation has been incurred. CKMS reports as a Business-Type Activity (BTA) as defined by GASB 35. BTA's are those activities that are financed in whole or part by fees charged to external parties for goods and services.

<u>Cash and Cash Equivalents</u>. Cash and cash equivalents include all highly liquid investments with a maturity of three months or less.

<u>Lease Assets.</u> Lease assets are initially recorded at the initial measurement of the lease liability, plus lease payment made at/or before the commencement of the lease term, less any lease incentives received from the lessor at/or before the commencement of the lease, plus initial direct costs that are ancillary to place the asset into service. Lease assets are amortized on a straight-line basis over the shorter of the lease term or the useful life of the underlying asset.

<u>Lease Asset Impairment.</u> CKMS evaluates lease assets for impairment whenever events or circumstances have occurred that indicate a significant, unexpected decline in the service utility of a lease asset. If a lease asset is tested for impairment and the magnitude of the decline in service utility is significant and unexpected, the accumulated amortization will be accelerated. The amount of the impairment loss will be recorded as the net book value divided proportionately over its remaining years of useful life. No lease asset impairment was recognized during the year ended June 30, 2024 and 2023.

<u>Operating Activities.</u> CKMS defines operating activities, as reported on the Statement of Revenues, Expenses, and Changes in Net Position, as those that generally result from exchange transactions, such as payments received for providing goods and services and payments made for services and goods received.

Income Taxes. CKMS is exempt from federal income tax under the Internal Revenue Code as a section 501(c)(3) organization.

<u>Use of Estimates.</u> The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to use estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The accompanying financial statements include estimates for items such as depreciable lives on capital assets and accrued liability accounts.

2. DEPOSITS AND INVESTMENTS

The fair value of deposits and investments, by type, at June 30, 2024 and 2023 are as follows:

<u>Deposit and Investment Policies.</u> CKMS follows the deposit and investment policies established by the University's Board of Trustees. Such policies are developed to establish and maintain sound financial management practices for the investment and management of CKMS's funds.

For purposes of investment management, CKMS's deposits and investments can be grouped into one significant category as follows: cash and cash equivalents on deposit with the University, which the University invests in deposits with banks.

Cash and cash equivalents on deposit with the University are managed within guidelines established by the University's Operating Fund Investment Policy, as approved by the Investment Committee of the University's Board of Trustees and maintained by the Operating Fund Investment Committee.

<u>Deposit and Investment Risks.</u> CKMS's deposits and investments are exposed to various risks including credit, interest rate and foreign currency risk, as discussed in more detail below.

<u>Credit Risk.</u> Credit risk is the risk that the issuer or other counterparty to an investment will not fulfill its obligation, causing CKMS to experience a loss of principal. Cash and cash equivalents on deposit with the University are governed by policy that minimizes risk in several ways. The University's deposits, in Federal Deposit Insurance Corporation (FDIC) insured financial institutions, are covered up to \$250,000 at each FDIC insured institution. State law requires that deposits in excess of this coverage be fully collateralized, therefore depository institutions issue a pledge of specific U.S. Treasury and/or U.S. agency securities, held in the name of the University by the Federal Reserve Bank, to cover all amounts over the \$250,000 coverage.

<u>Custodial Credit Risk.</u> Custodial credit risk is the risk that, in the event of the failure of the counterparty, CKMS will not be able to recover the value of its investment or collateral securities that are in possession of an outside party. Cash and cash equivalents on deposit with the University are invested in deposits held in the University's name. The University maintains records evidencing CKMS's ownership interest in such balances.

<u>Concentrations of Credit Risk.</u> CKMS's investments can be exposed to a concentration of credit risk if significant amounts are invested in any one issuer. Cash and cash equivalents on deposit with the University are not limited as to the maximum amount that may be deposited or invested in one issuer. However, the University's cash deposits in excess of federal deposit insurance are required to be fully collateralized by U.S. Treasury and/or U.S. agency securities or other similar investments as provided by KRS 41.240.

At June 30, 2024 and 2023, CKMS had no underlying investments in any one issuer which represented more than five percent of total investments, other than U.S. Treasury and agency obligations.

<u>Interest Rate Risk.</u> Interest rate risk is the risk that changes in interest rates will adversely affect the fair value of an investment. Cash and cash equivalents on deposit with the University have limited exposure to interest rate risk due to the short-term nature of the investment. The University requires that all deposits be available for use on the next business day.

<u>Foreign Currency Risk.</u> Foreign currency risk is the risk that fluctuations in exchange rates will adversely affect the fair value of an investment or deposit. CKMS is not exposed to foreign currency risk.

3. ACCOUNTS PAYABLE AND ACCRUED LIABILITIES

4. RETIREMENT PLAN

Eligible staff members of CKMS are participants in the University of Kentucky Retirement Plan. Under this plan, CKMS and plan participants make contributions to provide retirement benefits for employees. All payments were vested immediately for employees hired before January 1, 2010. For employees hired after that date, employee contributions are vested after three years, which was an amendment to the vesting rule adopted in 2013. CKMS contributes 10% of eligible compensation and employees contribute five percent of eligible compensation. CKMS's share of the costs of these benefits was \$2,007,371 and \$1,261,559 for the years ended June 30, 2024 and 2023, respectively. Employees contributed \$1,353,554 in 2024 and \$1,309,594 in 2023. CKMS's total payroll costs were \$31,102,370 and \$31,546,790 for the years ended June 30, 2024 and 2023, respectively. The total payroll for employees covered by the retirement plan was \$20,084,803 in 2024 and \$17,943,777 in 2023.

5. TRANSACTIONS WITH THE UNIVERSITY OF KENTUCKY

Office space is provided to CKMS by the UK HealthCare Hospital System at no charge. The fair rental value of the office space including utilities is recorded in other revenues and other expenses.

6. RISK MANAGEMENT

CKMS is exposed to various risks of loss related to torts; theft of, damages to, and destruction of assets; errors and omissions; injuries to employees; and natural disasters. These risks are covered by commercial insurance, extension of coverage by the University's participation in an insurance risk retention group or by self-insurance. The insurance coverage limit was up to \$1.00 billion per occurrence in 2024 and 2023. Settlements have not exceeded insurance coverage during the past three years.

The University is self-insured for the long-term disability income program and has established a 501(c)(9) trust for purposes of paying claims and establishing necessary reserves. The University also self-insures certain employee benefits, unemployment claims, and a long-term disability supplemental reserve, to the extent not covered by insurance. CKMS employees are covered under both of these University plans.

7. HEALTH INSURANCE BENEFITS FOR RETIREES

The University administers a single-employer defined benefit healthcare plan including medical and prescription drug benefits. CKMS may participate in this plan, which provides lifetime healthcare insurance benefits for eligible retirees and their surviving spouses. Human Resources Policies and Procedures define retiree health benefits and can be amended by the president of the University as delegated by the University's Board of Trustees (Board).

The University provides a pre-65 credit of up to 90% of the "true retiree" cost of the least expensive pre-65 medical plan. For post-65 benefits, the University provides a credit equal to 90% of the "true retiree" cost of the post-65 medical plan. However, retirees must pay the greater of \$100 per month or 10% of total plan cost. The University has established a trust fund to segregate plan assets and the contribution requirements of plan members and the University are established and may be amended by the president of the University. The University contributed to the OPEB trust based on an actuarially determined rate in accordance with the parameters of GASB Statement No. 75, *Accounting and Financial Reporting for Postemployment Benefits Other Than Pensions*.

CKMS has recognized its share of the contribution in employee benefit costs and has no additional liability for this benefit at June 30, 2024 and 2023.

8. LONG-TERM DISABILITY (LTD) BENEFITS

The University of Kentucky LTD plan is administered through the University's LTD trust fund as an irrevocable trust. The trust pays claims and establishes necessary reserves. The trust is not a separate legal entity and is governed by the University's Board. The coverage of the LTD benefits are established and may be amended by the president of the University.

Regular employees with a full-time equivalent of 0.75 or greater who have completed 12 months of service are automatically enrolled in the plan. To be covered, an employee must be actively at work on the first day of

the month after the employee completes one full year of service. An employee approved for long-term disability receives benefits based on the employee's basic regular monthly salary at the time of the onset of the disabling condition. Primary income benefits provide payment of 60% of the basic regular monthly salary less any disability received from government programs and/or another employer for the same condition. Basic salary for medical faculty is defined as the tenure base salary. Other sources of income used in the benefit formula include Social Security, worker's compensation or other similar government programs, veterans' or other governmental disability payments, or other employer-sponsored disability benefits.

The University has established a trust fund to segregate plan assets and the contribution requirements of plan members and the University are established and may be amended by the president of the University. The University contributed to the LTD trust based on an actuarially determined rate in accordance with the parameters of GASB Statement No. 75.

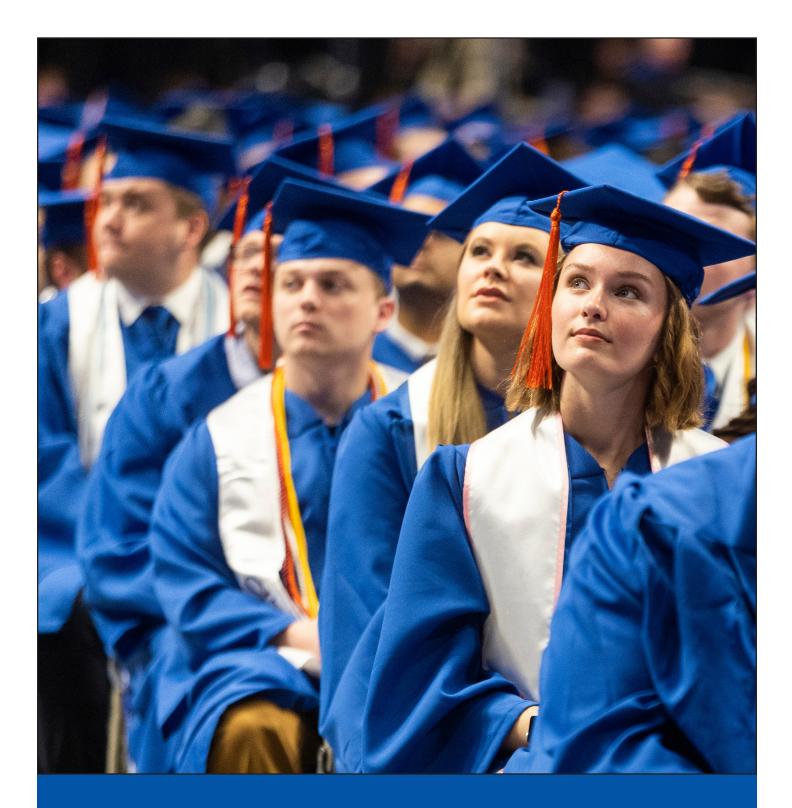
CKMS has recognized its share of the contribution in employee benefit costs and has no additional liability for this benefit at June 30, 2024 and 2023.

9. SUBSEQUENT EVENTS

Effective July 1, 2024, CKMS will no longer provide staffing services to UK HealthCare and all CKMS employees, including Eastern State Hospital employees, will become UK employees. Therefore, healthcare staffing services revenue as well as related personnel expenses will no longer be recorded by CKMS. CKMS will source staffing from UK Healthcare to perform collection services.
